Consiliul local al municipiului Constanța întrunit în ședința ordinară la data de 16.05.2011 ;

Analizând expunerea de motive a d-lui Primar Radu Ștefan Mazăre , raportul Comisiei nr.1 de studii, prognoze economico-sociale, buget-finanțe, administrarea domeniului public și privat , raportul Direcției Financiare nr. 63.317/29.04.2011 și raportul Serviciului Public de Impozite, Taxe și alte venituri ale bugetului local nr.62.608/28.04.2011;

Având în vedere prevederile Legii nr. 273/2006 privind finanțele publice locale cu modificările ulterioare , Legea 571/2003 privind Codul Fiscal și art.295, pct.287, alin.2 din H.G.44/2004 privind aprobarea Normelor metodologice de aplicare a Legii nr.571/2003 privind Codul Fiscal;

În temeiul prevederilor art.36 ,alin. 2, lit.b, alin. 4, lit. a și art.115 alin.1, lit. b din Legea nr/215/2001 privind administrația publică locală, republicată;

## **HOTĂRĂȘTE :**

**Art.1** Se aprobă contul de execuție al bugetului local al municipiului Constanța pe anul 2010, prezentat în anexele nr.1 și 1a, care fac parte integrantă din prezenta hotărâre.

**Art.2** Se aprobă excedentul în suma de 76.007.962 lei rezultat în urma veniturilor realizate în anul 2010 în sumă de 510.029.597 lei și a cheltuielilor în sumă de 434.021.635 lei .

**Art.3** Se aprobă contul de execuție a veniturilor și cheltuielilor evidențiate în afara bugetului local, prezentat în anexele nr.2 și 2a, care fac parte integrantă din prezenta hotărâre.

**Art.4** Se aprobă veniturile evidențiate în afara bugetului local realizate în anul 2010, în sumă de 97.341.656 lei și cheltuielile în sumă de 99.518.252 lei ;

**Art.5** Se aprobă excedentul anului 2010 în sumă de 88.089.960 mii lei în următoarea structură:

- 78.554.301 lei – fondul de rulment constituit conform legii în anul 2010
- 6.301.253 lei –fondul de rulment al anului 2009
- 3.110.047 lei taxe speciale
- 124.359 lei – depozite speciale pentru construcții de locuințe
